The acceptance of this responsibility by the Voluntary Agency will be signified by an endorsement stamped in the margin of Page 3 of Form DSR-8 reading 'Agency Endorsed Job Assurance' and by the signature in Section 3 of this form of an authorized officer of the recognized Voluntary Agency's National Headquarters. The assurance Form DSR-8 should contain the following data: (a) Type of employment or name of job; (b) Desirable special skills or other qualifications required. This space should be used to describe the experience, physical condition, education, or other basic factors necessary or required by the employer; (c) Address of place of employment; (d) Terms of employment. Included in this space should be the rate of pay, either hourly, weekly or monthly, including room and board, tips or any other remunefation which might be a part of the total compensation to be paid; a statement that such wages are prevailing wages, in the area of employment; the hours of work; and whether or not the position offered is permanent, indefinite or temporary. A brief summary of the duties involved in the job offer should likewise be included; or
- 3: A recognized Voluntary Agency may accept the responsibility for recommending to the Administrator that an assurance for a specified employment category in a particular locality is bona fide and authentic. The acceptance of this responsibility by the Voluntary Agency will be signified by an endorsement stamped in the margin of Page 3 of Form DSR-8 reading 'Agency Endorsed Job Assurance' and by the signature in Section 3 of this form of an authorized officer of the recognized Voluntary Agency's National Headquarters. The assurance Form DSR-8 should contain the following employment data: (a) Specfic employment category in a particular locality (City or County); (b) Desirable skills or other qualifications required. This space should be used to describe the experience, physical condition, education or other basic factors necessary or required by the employers in the job category; (c) Address of place of employment will be care of the sponsor; (d) Name and address of employer will be given as care of the sponsors; (e) Terms of employment. Included in this space should be the rate of pay, either hourly, weekly or monthly, including room and board, tips or any other remuneration which might be a part of the total compensation which is being paid to employees engaged in this specified employment category and which will be paid to the alien after arrival in the United States; a statement that such wages are prevailing wages in the area of employment; the hours of work; and whether or not the position offered is permanent, indefinite or temporary. A brief summary of the duties involved in the job offer should likewise be included.

When procedure No. 3 is used, it shall be the obligation of the recognized Voluntary Agency to notify the Administrator of the specific job, the address of the place of employment and the name and address of the actual employer where the alien has, after arrival in the United States, been employed. This notice shall be sent to the Administrator as soon as possible following the arrival of the alien at his destination in the United States.

In connection with procedure No. 1 the finding and recommendation of the United States Employment Service is an advisory opinion which will be used by the Administrator in deciding whether or not to verify the assurance of employment.

- In connection with procedures 2 or 3, the recommendation and endorsement of a recognized Voluntary Agency will be used by the Administrator in deciding whether or not to verify the assurance of employment. If the employment data is not deemed sufficient by the Administrator, the endorsing Agency may be requested to submit additional employment data.

Section 14(c) of the Refugee Relief Act of 1953 provides that any person who knowingly violates any provision of this Act is guilty of a felony and may be fined not as 5000 more than \$10,000 as be imprisoned not more than ten years, or both.
