Established in 1986 as a ministry of the El Paso Diocese, they work to protect the rights of immigrants. In 2023, they provided a record 57,248 services to people from 60 countries around the globe.

Estrella del Paso, formerly Diocesan Migrant & Refugee Services, Inc., proposes to add new citizenship classes and a comprehensive outreach effort seeks that will enhance its services. The organization empowers eligible individuals to take steps toward naturalization, with support from the largest provider of immigration legal services in the area. Dear Senator Heinrich:

Thank you for your August 21, 2024 letter to the Department of Homeland Security (DHS) regarding the application from Estrello del Paso to the Fiscal Year (FY) 2024 Citizenship and Integration Grant Program (CIGP). I am responding on behalf of the Department.

As you may know, as part of the Consolidated Appropriations Act, 2024, Congress authorized \$10 million in funds to support the FY 2024 CIGP. USCIS published two Notices of Funding Opportunity under the CIGP. Through these opportunities, USCIS will offer up to \$10 million in competitive funding for organizations that help prepare immigrants for naturalization and promote civic integration through increased knowledge of English, U.S. history, and civics. The USCIS Office of Citizenship is currently conducting a technical review of grant proposals.
