I write today to urge you to redesignate TPS for Nicaragua. Last year, there was hope in the Nicaraguan community that this administration was ready to redesignate TPS. However, this hope has so far failed to materialize. Yet since that time, the situation has deteriorated even further. Attacks on Catholics and the Catholic Church have intensified.

The 2023 report by the United States Commission on International Religious Freedom, documents that since 2018 the assault on the clergy has worsened². While the persecution began in 2018, 2022 was the first year that the regime detained and jailed members of the clergy. Earlier this year, Pope Francis highlighted the growing attacks on the Catholic Church underscoring the need for basic religious freedom in Nicaragua. Here in the Archdiocese of Miami, we have welcomed and assisted many political prisoners, including religious leaders, released through the efforts of the US State Department.

The 2022 Religious Freedom Report from Secretary of State Anthony Blinken was alarming. Dear Archbishop Wenski:

Thank you for your November 26, 2024 letter to the Department of Homeland Security (DHS) requesting that Nicaragua be redesignated for Temporary Protected Status (TPS). I am responding on behalf of the Department.

I appreciate the concerns you have outlined regarding the situation in Nicaragua and your interest in its redesignation for TPS. Please be assured DHS is monitoring conditions in Nicaragua. DHS is committed to administering its programs, including TPS, in an equitable manner, pursuant to specific statutory criteria. As required by the statute, at least 60 days before the expiration of a foreign state's TPS designation or extension, the Secretary, after consultation with appropriate Government agencies, must review the conditions in the foreign state to determine whether conditions for the TPS designation continue to be met. DHS will consult with other government agencies to explore whether to extend or redesignate Nicaragua for TPS.

U.S. Citizenship and Immigration Services (USCIS) also offers support that may be available upon request to assist eligible noncitizens affected by emergencies or unforeseen circumstances.² Such support may include:

- Change or extension of nonimmigrant status if eligible nationals are currently in the United States, even if the request is filed after the authorized period of admission has expired;
- Expedited processing of requests for advance parole documents;
- Expedited adjudication of requests for off-campus employment authorization for F-1 students experiencing severe economic hardship;
- Expedited adjudication of employment authorization applications, where appropriate;

- Assistance if applicants received a Request for Evidence or a Notice of Intent to Deny and were unable to appear for an interview, submit evidence, or respond in a timely manner because of the emergency or unforeseen circumstances; and
- Replacement of lost or damaged immigration or travel documents issued by USCIS, such as a Permanent Resident Card (Green Card).
