
Operational Updates



- Effective May 6, 2024, initial domestic processing of Form I-730 following-to-join refugee (FTJ-R) petitions shifted within RAIO from the Asylum Vetting Center (ZGA) to Refugee and International Operations (RIO).
- The International Operations (IO) part of RIO has a dedicated unit to support this workload.

Form I-730 Processing





Transfer Notice

U.S. Citizenship and Immigration Services

- The transfer notice will indicate the office we transferred your Form I-730 FTJ-R petition to.
- Legal representatives will receive a copy of the receipt and transfer notices.
- USCIS will soon send Notices of Transfer to International Operations, indicating we sent your petition from the Asylum Vetting Center to International Operations.
- Allow up to 8 weeks for petitions to be transferred to International Operations.

As part of standard processing USCIS is transferring certain Form I-730 Refugee/Asylee Relative Petitions, including the petition for the above-referenced beneficiary, to USCIS International Operations (Washington, DC).

Please allow eight (8) weeks for the petition to reach International Operations. You will not receive a new receipt notice. If you have any questions about your petition, contact USCIS at egov.uscis.gov/e-request/Intro.do

If your physical address or mailing address changes while the petition is pending, please notify USCIS using the Online Change of Address option or downloading form AR-11 at www.uscis.gov/addresschange to ensure you receive updated notices about this petition.

Change of Address



- **IMPORTANT**: Please notify USCIS if the contact information for your Form I-730 changes.
- To update your or your beneficiary's address in the United States, follow the instructions on How to Change Your Address at <u>uscis.gov/addresschange</u>.



International Operations



- IO's dedicated unit will complete initial domestic processing of all Form I-730 FTJ-R petitions, as well as processing of Form I-730 beneficiaries at USCIS international offices outside the United States.
- Will improve consistency and efficiency in processing.
- International Operations is not a public-facing office.
- The Asylum Vetting Center no longer processes Form I-730. Do not contact or visit them for information about your Form I-730.

USCIS International Offices



- New international field offices in Tegucigalpa, Honduras; Doha, Qatar; and Ankara, Türkiye.
- Staff will interview Form I-730 beneficiaries in these countries.
 This responsibility is transitioning from the Department of State consular staff to USCIS.
- USCIS adjudicators who focus on Form I-730 processing can support FTJ petitions for Afghan beneficiaries at Camp As Sayliyah (CAS).
- USCIS has 11 international field offices that conduct Form I-730 interviews of beneficiaries.

Form I-730 Eligibility



- Only principal refugees or asylees can file a Form I-730 petition for followingto-join benefits.
- If you were admitted to the United Status as a derivative or accompanying refugee or asylee, you are not eligible to file Form I-730 for your spouse and children.
- If you have a pending refugee or asylee application, you are not (yet) eligible to file Form I-730 for your spouse and children, and we may deny your Form I-730.
- You must file Form I-730 within 2 years of your admission to the United States or grant of asylum.
- Petitioners may file for their spouse and unmarried children under the age of 21.

Customer Service



- Updated guidance and information on Form I-730 processing for USCIS Contact Center staff.
- Working to expand the USCIS Policy Manual to enable the USCIS Contact Center to respond to Form I-730 inquiries from petitioners directly.
- Working to expanding processing times on the USCIS
 Processing Times website to account for all USCIS offices that work on Form I-730 petitions for domestic and international processing.

Requests for Evidence



 USCIS conducted an internal review of templates for Requests for Evidence and denials.

 USCIS revised templates to clearly detail and indicate the specific information or documentation we are requesting and why we need it.

USCIS Policy Manual and Form Revision



- USCIS is working on updates to the USCIS Policy Manual and Form I-730:
 - A new policy manual section on relative petitions for refugees and asylees.
 - An update to the USCIS Policy Manual so the USCIS Contact Center can respond to inquiries from Form I-730 petitioners. This will allow us to expand our customer service options and provide greater clarity to petitioners.
 - A revision to update Form I-730.
- These updates are currently under development, and we will provide more detailed information when they are finalized.

Form I-730 Data Snapshot




- As of May 28, 2024, approximately:
 - 25,900 Form I-730 petitions are pending initial domestic processing.
 - 9,600 petitions are pending an interview and additional processing with USCIS.
 - 16,500 petitions are pending interview and additional processing with the Department of State.

Processing of Afghan Beneficiaries



- As of May 28, 2024, approximately:
 - 7,800 Form I-730 petitions are pending with USCIS for Afghan beneficiaries.
 - 7,200 are FTJ-A petitions.
 - 645 are FTJ-R petitions.
